John Crews II 1800-1875

As with many of the records for the older Wiregrass pioneers, John Crews' are inconsistent, at best. Judge Huxford, in his Pioneers of Wiregrass Georgia book Volume 5 reports John Crews (II) was born in the Beaufort District of South Carolina (1). However, son John III states his father was born in Georgia (2). Depending on which census is viewed, his birth date is either 1800 or 1805. With his son John being referred to as John III and his grandson John IV, it is safe to say he is John II and is a son of John Crews I (1).

Judge Huxford states John and his brothers, Joseph Crews and Samuel Crews, and possibly others of his family, came to Camden County, Georgia in their early adulthood, where they married (1). These brothers and likely their mother were counted here in 1830. A closer look at the below 1830 Census record seems to support the Judge's statement. There are four adult males and one female that appears to be a generation older. This could be John, 1790 Samuel, 1805 Joseph, and another late arrival to Camden County, Elias and perhaps their mother. Huxford has shown three were born in Beaufort County, SC. The fourth, Elias, is unknown however, there is no record of Elias until his 1831 marriage to Mary Beasley in Camden.

John Crews married Catherine Prevatt, born 1807 in McIntosh County, daughter of James D. Prevatt who was an early settler of Wayne, later moving to Hamilton County, Fla. The couple's marriage occurred sometime after the 1830 Census for Camden County; GA was taken.

Huxford states the family moved briefly into Columbia County (now Baker), Florida (1) after the 1830 enumeration. There seem to be no records to support this statement.

About a year later they moved back into Georgia and settled in the 13th land district of what was then Ware County, now Echols, living near Bethel Church on the west side of the Suwannee River. The family seems to have lived at this location for several years as John's military records in the 2nd Florida War indicate he traveled eighty miles to Jacksonville to the August 1837 Muster and eighty miles back. The Baker County locale is much closer than the reported eighty miles and is close to the Echols location.

John Crews fought in the Indian War in 1837-39. His bounty-land application executed in Columbia County, Fla., May 27, 1852, showed that he was a 2nd Corporal in Capt. James Green's company, 1st Regiment, Florida Volunteers,

from Aug. 3, 1837, to Dec. 31, 1837, and again Nov. 1, 1838, to Jan. 31, 1839. His application was granted (7) (1).

The family seems to have moved back to Camden after John's two hitches in the Florida War as the next records uncovered for his family report Mr. and Mrs. Crews were members of the Bethel Primitive Baptist Church. Records of Bethel Church above referred to show they were received Jan. 7, 1844, by letter from Baileys Branch Church in Camden County, and were dismissed by letter, having moved back to Florida. Their later church membership has not been traced. Their oldest daughter, Mary Ann, was a member of Bethel also, but did not move her membership from there until May 5, 1876.

By the time the 1850 census is taken, the John Crews (Cruse as it is spelled in this Population Schedule) is enumerated in Columbia County, Florida. An interesting note is John and Catherine are living next door to Samuel and Elizabeth Cruse (Crews)

The 1850 Slave Schedule for Columbia shows John has one black male age 45, 1 black female age 15, and a female mullato age 5 months (6).

With the proximity of Samuel, John appears to be living in what will later be Baker County, Florida.

On 1 May 1855, John Crews of Columbia County, Florida obtained forty acres of land from the Federal Government (8).

It is not known how much longer the family lived in Columbia but, by 1860 they were enumerated in the 22nd District of St Johns County, Florida. John had some familiarity with this area as he was mustered in for his second hitch in the War with the Seminoles (1938) in St Augustine, FL He was mustered out in Jan of 1839 from the same location.

About six years later they moved back to Columbia County, Fla., and lived for a few years in the part made about 1858 into Bradford (now Union) County (1).

Mr. and Mrs. Crews spent their last years in present Columbia County where they died; John on 7 March 1875 (9) and Catherine about 1877. They are buried at Oak Grove Baptist Church in Columbia county, north of Lake City. Florida.
